#### DESCRIPTION

SikaGrind<sup>®</sup>-306 is a chloride free liquid additive designed to allow easier grinding of cement.

#### USES

SikaGrind<sup>®</sup>-306 can be used in general for all cement types in order to:

Increase the production rate

Improve the efficiency of the mill and separator

SikaGrind<sup>®</sup>-306 is a very effective dispersant with the following characteristics:

- It reduces the cement particle agglomeration by neutralizing the surface electrical charges
- Improves the cement hydration process and therefore the strength development

- Higher mill and separator efficiency, offering significant production increase and decreasing the energy costs
- Reduces the "coating" formation, maintaining the effectiveness of the ball charge.
- The distribution of the particle size is improved, avoiding the formation of the "over milled" particles
- It intervenes in the cement hydration process, enhancing strength development, especially at early phase
- Reduced silos blockage risk
- Due to its effectiveness as a dispersant, it enables easier handling operations (pneumatic conveyors, silo extraction, e.t.c.)

#### **APPLICATION INFORMATION**

Recommended Dosage	Typical dosage rates of SikaGrind®-306 are between 0,3 -0,6 kg per tonne of cement (0,03% - 0,06% of total weight = cement clinker + additions). The optimum dosage to achieve the desired characteristics shall be determined in plant trials. Influencing factors are e.g. the properties of clinker source, type of cement and other plant variables. For consistent results, SikaGrind®-306 must be accurately dispensed.
Compatibility	Cements treated with SikaGrind <sup>®</sup> -306 are compatible in concretes pro- duced with all commercial admixtures including air entrainers, water redu- cers, retarders and superplasticizers. The performance of concrete admix- tures is not adversely affected by the use of SikaGrind <sup>®</sup> -306.
Dispensing	SikaGrind®-306 shall be added onto the clinker feed shortly before the mill entrance or directly into the grinding mill (first or second compartment). Suitable dosage pumps with adjustable flow rates shall be used for accur- ate dosing. Note: Periodically, the end of the additive tube/hose shall be checked to ensure that it is not blocked.
