Installation procedure

Strictly follow installation procedures as defined in method statements, application manuals and working instructions which must always be adjusted to the actual site conditions.

Fixing method - General

The product is installed by loose laying.

The filter fleece alternately overlaps the drain core on each side by approximately 10 cm. The filter fleece must overlap on one longitudinal and one narrow side. Change-over sections and closing-off sections must be covered with a fleece strip. SikaRoof® Drainage Layer 20L2F must be secured with ballast (soil and plants) immediately after installation.

IMPORTANT CONSIDERATIONS

Installation work must only be carried out by Sika® trained and approved contractors, experienced in this type of application.

- The use of SikaRoof® Drainage Layer 20L2F membrane is limited to geographical locations with average monthly minimum temperatures of -50 °C. Permanent ambient temperature during use is limited to +50 °C.
- The use of some ancillary products such as adhesives, cleaners and solvents is limited to temperatures above +5 °C. Observe temperature limitations in the appropriate Product Data Sheets.
- Special measures may be compulsory for installation below +5 °C ambient temperature due to safety re-
