- Under certain conditions, underfloor heating or high ambient temperatures combined with high point

loading, may lead to imprints in the resin.

• If heating is required do not use gas, oil, paraffin or other fossil fuel heaters, these produce large quantities of both CO2 and H2O water vapour, which may adversely affect the finish. For heating use only electric powered warm air blower systems.
